II. PROGRAM UPDATES

A. RTA- Claire Serdiuk

At the last RTA board meeting a strategic COVID Recovery Planning Group was unveiled. RTA currently has a survey available on their website that will be used to format the 2021 work plan and will address how transportation will have to change in the future.

B. METRA- Noe Gallardo

Ridership has taken a huge hit due to COVID. Metra has also added a ridership dashboard, which shows the average number of commuters on train cars, to their

website to help riders plan their trips. Metra is working with New Lenox on their new train station, Manhattan on renewing and resealing their train platform, and Mokena on getting a few repairs for their station.

C. Pace- Beth Gonzales

Pace operations have transitioned due to COVID. This includes the suspension of routes throughout the whole system. The Will County routes that are impacted are: Lewis & Route 504. Lewis run will resume in January, at the college's request. Route 504 is currently running on a reduced schedule. Current ridership is at 50%, however there are some routes that are seeing higher ridership numbers. The Plainfield garages targeted to open in the end of 2021 and the Joliet transit center has been delayed.

D. ISTHA- Lauren Platt

The Illinois Tollway is working fully remote. Stressed the importance of being safe on the roadway and if pulled over on the system please remain in car. The commercial volume on the system is back to normal while the passenger traffic is bouncing back but remains about 20% down. Shared information about the Tolling 2020 reform which uses invoicing for missed tolls while also lowering the fees for missed tolls.
